# **Funding Information**

### Am I eligible for 30 hour funding?

- Your child will be aged 3 or 4 when the scheme starts
- You live in England
- Both parents must be working or the sole parent is working in a lone parent family
- Each parent earns, on average, a weekly minimum equivalent to 16 hours at National Minimum Wage or National Living Wage
- Each parent must have an annual income of less than £100,000

### How do I apply for the 30 hours free childcare?

Please visit the gov.uk site for childcare. You can either apply for Tax-Free Childcare or 30 hours free childcare and sign into your childcare service account here. It's one single application but they will check your eligibility for both. When you start you will temporarily leave the site to verify your identity. Once your identity's been verified, you'll be brought back to the site to complete your application. You will then get a childcare service account.

### I am eligible for 30 hour funding. What do I do now?

After you have applied online through the childcare service you will receive a code. Please write your code in the space below or give the code directly to us, along with your national insurance number and date of birth.

## What if I am not eligible for 30 hours funding? Do I receive any funding?

Each 3 or 4 year old child will still be entitled to 15 funded hours per week at a pre-school setting from the beginning of the term following their 3rd birthday. Parents will also be able to sign up for tax free childcare to pay for any additional hours. #### Will I get funding for my 2 year old?

Depending on income levels, some 2-year-olds can get free childcare if the parents are claiming one of the following:

- Income Support
- Income-related Employment and Support Allowance (ESA)
- Income-based Jobseeker's Allowance (JSA)
- Universal Credit

- The guaranteed element of State Pension Credit
- Child Tax Credit and/or Working Tax Credit and have an annual income under £16,190
- The Working Tax Credit 4-week run on (you get this when you stop qualifying for Working Tax Credit)
